

AMENDMENT NO. 2

COLLEGE AND CAREER ACCESS PATHWAYS PARTNERSHIP AGREEMENT
BETWEEN
SANTA CLARITA COMMUNITY COLLEGE DISTRICT ("COMMUNITY COLLEGE DISTRICT")
AND
WILLIAM S. HART UNION HIGH SCHOOL DISTRICT ("SCHOOL DISTRICT")

JULY 1, 2018 – JUNE 30, 2023

This Amendment No. 2 ("Amendment No. 2") to the College and Career Access Pathways Partnership Agreement approved by the COMMUNITY COLLEGE DISTRICT's Board of Trustees on October 24, 2018, and any subsequent Amendments (collectively "CCAP Agreement"), is entered into by and between COMMUNITY COLLEGE DISTRICT and SCHOOL DISTRICT.

NOW, THEREFORE, it is understood and agreed by the Parties hereto that:

1. Sections 8.5, 8.6, and 8.7 of the CCAP Agreement shall be deleted in their entirety and replaced with the following:
 - 8.5 Students enrolled in COMMUNITY COLLEGE DISTRICT courses offered as part of this CCAP Agreement who have approved Section 504 Plans and who seek accommodation(s) from the COMMUNITY COLLEGE DISTRICT to participate in CCAP courses must apply for accommodation(s) with the COMMUNITY COLLEGE DISTRICT's Disabled Student Programs and Services ("DSPS") office and provide a copy of their Section 504 Plan. Students may also need to provide additional documentation, which further indicates a diagnosis. DSPS will determine the appropriate accommodation(s) pursuant to its procedures. The COMMUNITY COLLEGE DISTRICT cannot and will not modify its curriculum to accommodate a student.
 - 8.6 The COMMUNITY COLLEGE DISTRICT has no responsibility for implementing any portion of a student's Individualized Education Program ("IEP"). Students enrolled in COMMUNITY COLLEGE DISTRICT courses offered as part of this CCAP Agreement who seek accommodation(s) from the COMMUNITY COLLEGE DISTRICT to participate in CCAP courses must apply for accommodation(s) with DSPS. DSPS will determine the appropriate accommodation(s) pursuant to its procedures. The COMMUNITY COLLEGE DISTRICT cannot and will not modify its curriculum to accommodate a student.
 - 8.7 The COMMUNITY COLLEGE DISTRICT shall provide a Notice to Students/Parents that outlines the rights and responsibilities of students participating in the CCAP Program under its policies and procedures, including the respective responsibilities of the COMMUNITY COLLEGE DISTRICT described in this Section of this Agreement. Additionally, the SCHOOL DISTRICT shall provide a Notice to Students/Parents that outlines the rights and responsibilities of students participating in the CCAP Program, and the responsibilities of the SCHOOL DISTRICT described in this Section of this Agreement.
2. Except as set forth herein, all other sections, subsections and provisions of the CCAP Agreement shall remain valid and enforceable.
3. The individuals executing this Amendment No. 2 on behalf of the Parties represent and warrant that they are authorized to do so.
