### Board Bylaws

Student Board Members

Student Communications Council

#### Purpose

It shall be the purpose of the Student Communications Council to provide a communication link between the general student body of the school district and the student member of the Governing Board.

#### Composition

The Student Communications Council shall consist of two representatives from each comprehensive high school, and one representative from each of the following school entities: Bowman ~~Continuation~~ High School, Learning Post, Academy of the Canyons, Sequoia ~~Charter~~ School, and each junior high school.

#### Officers

The officers of the Student Communications Council shall consist of a President, Vice President, Secretary, and Student Board Member. Officers will serve no more than one school year in any one office.

#### Duties

1. President - Organize and preside at all meetings of the Council and serve in lieu of the Student Board Member - student who is a junior or senior.
2. Vice President - serve in lieu of the President and assume other duties assigned by the President - student who is a junior or senior.
3. Secretary - compile and distribute minutes of all meetings of the Council and notify members of the meeting schedule.
4. Student Board Member - represent the Council and general student body pursuant to Board Bylaw ~~9110~~ **9150** - student who is a senior.

## Selection

Representatives to the Student Communications Council shall be elected in accordance with rules and regulations established primarily by this Administrative Regulation and secondarily by the student body government at each school site. The representative shall be elected to serve a one school year term. Representatives must have and maintain a minimum grade point average of 2.5.

## Meeting Schedule

The Student Communications Council shall meet on a regular basis during the school year. The date, time, and place of the Council meetings will be determined annually by the ~~student representatives~~ **office of the Superintendent**. ~~Meetings during vacation periods shall be scheduled at the discretion of the Council.~~

## Administrative Advisor

A district-level administrator, usually the Superintendent, will serve as advisor to the Council.

## Election of Student Board Member

No later than the second meeting of the Student Communications Council, the ~~high school representatives serving on~~ **members of** the Communications Council shall elect one high school senior member of the council to serve as the ~~non-voting~~ **Student Board Member**. ~~of the Board.~~ The Student Board **Member** shall serve for one school year, and the responsibility shall be as authorized in Board Bylaw ~~9110~~ **9150** and appropriate sections of the Education Code.

## Internal Operation of the Council

The Student Communications Council may adopt such rules and procedures as it deems necessary for its operation. Such procedures should provide for the election or appointment of new members and/or ~~Student Board~~ **Member** in case of vacancies.
