Saugus High School parent Larry Alvarez said he is grateful to the school staff, commended Vince Ferry, and said the District needs to work on prevention measures and update security plans.

Canyon Country resident Jack Kurtz said there is security at a Dodger game but not at a high school football game. He urged not to forget lives lost by making sure that nothing like this never happens again, and he requested that safety be a continued agenda item.

State Senator Scott Wilk said that while all agree more needs to be done toward school security, the Hart District has been proactive, and he is very impressed with the response of students and staff. He mentioned that the state auditor read the Saugus High School safety plan and remarked that it is the most thorough he has seen for a school.

Mr. Peschek explained that the adopted budget is based on May projections, the unaudited actuals reflect 2018/19 ending balances, and the first interim is based on the current, adopted state budget. He reviewed Local Control Funding Formula allotments and the supplemental and mandate block grants. He discussed ongoing and one-time funding and the effect on multiyear planning and differences between the adopted budget and first interim numbers. He said there is a \$12.9 million operating deficit for 2019/20, and projections show deficit spending of \$12.9 million for 2020/21, \$871,000 for 2021/22, and smaller deficit balances for the following two years. It has been predicted that the COLA (cost of living adjustment) could be smaller this year, which would have a significant impact to budget projections and could result in negative certifications. Copies of the report and presentation are attached to the agenda of this meeting.
