**RESOLUTION OF THE GOVERNING BOARD OF THE WILLIAM S. HART  
UNION HIGH SCHOOL DISTRICT IN SUPPORT OF SULPHUR SPRINGS  
UNION SCHOOL DISTRICT SCHOOL FACILITIES BOND MEASURE US**

**WHEREAS**, the William S. Hart Union High School District (“Hart”) and the Sulphur Springs Union School District (“Sulphur Springs”) in Los Angeles County, State of California (the “State”), are committed to providing a quality education to all their students; and

**WHEREAS**, State funding and local revenue sources do not provide adequate funding necessary to fund all capital improvement needs of school districts; and

**WHEREAS**, the Board of Trustees of Sulphur Springs has called an election to submit to the electors of Sulphur Springs the question of whether bonds shall be issued and sold for the purpose of raising money for the acquisition and improvement of real property and the furnishing and equipping of school facilities (“Measure US”); and

**WHEREAS**, the Board of Trustees of Sulphur Springs supports the improvement of education outcomes through the renovation and construction of school facilities; and it is in the Board’s interest to ensure that current students of Sulphur Springs are ready for matriculation into high school; and

**WHEREAS**, the Board of Trustees of Sulphur Springs hereby finds that student and staff safety is of paramount importance; and Measure US could fund safety and security equipment such as cameras, alarms, and fire protection system improvements; and

**WHEREAS**, Measure US could increase access to science, technology, engineering, math, and arts instruction; modernize classrooms and labs; upgrade security and emergency communication systems; and replace aging portable classrooms; and

**WHEREAS**, the passage of Measure US would allow Sulphur Springs Union to repair, renovate, and construct facilities, provide adequate technology and security, and improve the educational experience for students in the District’s service area; and

**WHEREAS**, the Hart Governing Board believes there will be benefits to students in the community and to the community’s well-being in general from passage of the Measure US.

**NOW THEREFORE BE IT RESOLVED**, that the William S. Hart Union High School District supports the placement of Measure US, a \$78 million school bond measure, on the ballot for the March 3, 2020, primary election within the boundaries of the Sulphur Springs Union School District; and encourages eligible voters to cast a vote in such election.
