
The following contract between William S. Hart School District, hereby known as "The District," and Riddell/ All- American, hereby known as "Vendor," has been established to create a mutual partnership for the reconditioning of football helmets and shoulder pads. The attached pricing quote outlines the costs to be charged by the Vendor to The District on a yearly basis. The following conditions have been agreed by both parties.

- A. The Vendor agrees to keep the pricing the same for the length of this agreement, which shall run for one (1) year.
- B. The Vendor will provide pickup at the request of each school. Equipment will be returned to the school, no later than 7/1 each year.
- C. Vendor will invoice the district within 30 days of completion of service, with Terms NET 30.
- D. An accurate count and list of equipment will be given to each site at the time of pickup.
