Miss Friedman said Valencia High School's Associated Student Body is putting together senior gifts, families are hanging padlocks on the gates at Hart High School to remember the Class of 2020, and she has recorded a speech for her school's virtual graduation. She thanked everyone for working to create virtual graduations.

V.C.1. Hart District Teachers Association (HDTA) President John Minkus

Mr. Minkus thanked Miss Friedman for her student activism. He recognized classified employees and said they are necessary for schools to work. He said HDTA will play a complimentary role in dealing with the hardships resulting from the current crisis and HDTA will do all they can to support teachers and be honest and forthright in dealings with District administration. He announced that the California Teachers Association and HDTA are supporting the HEROES (Health and Economic Recovery Omnibus Emergency Solutions) Act. V.D. School Site Report - Hart High School

Hart High School Principal Jason d'Autremont said one of the missions at the beginning of school year was to increase parent and student engagement. He discussed engagement efforts prior to Distance Learning including Hart Parent Organization (HPO) meetings, HPO updates on Facebook live, the Hart to Hart podcast, installation of an electronic marquee, quarterly Padres Unidos meetings, Twitter updates, and mobile hotspots purchased through Title I funds and made available for students to check out through the library. Then he reviewed additional programs and events that were added after the transition to Distance Learning. These include virtual library nights for intervention, Instagram postings, Wise Words, the Thursday Staff Spotlight, Monday emails to students, and Friday Facebook Live events. He said the school has passed out over 400 Chromebooks and is planning to purchase more hotspots for next year, and he discussed the efforts and support of teachers using Google Classroom. He also said that emails, Facebook live events, and library night support are all available in Spanish. He mentioned that there will be drive-through cap and gown and senior award distributions and textbook collections next week. A copy of the presentation is attached to the agenda of this meeting.

VIII.A. Citizens' Oversight Committee Report on 2018/19 Measure SA Expenditures

Measure SA Citizens' Oversight Committee Chairperson Suzan Solomon said the Committee has reviewed the annual Measure SA performance audit, finds that the District is in compliance with the requirements of Proposition 39, and accepts the report as presented. A copy of the report is attached to the agenda of this meeting.

VIII.B. Overview of California Governor's May Budget Revise

Mr. Peschek reviewed the governor's May budget revise, released on May 13. He said this document is used to develop school budget projections for the next three years and the legislature and governor have until June 30 to pass and sign the actual budget. After that, the District budget, with actual closing numbers and adopted state budget information, is updated and presented to the Board in August. However, this year's budget process will be different. Economic expansion has halted and the shift of federal and state tax deadlines have caused significant declines in revenue. The May revise assumes a \$41.2 billion loss in state revenues for 2019/20 and 2020/21. The governor has proposed to expend the state rainy day fund over three years from 2019/20 to 2021/22 to help mitigate the losses. Local budgets must be adopted by July 1, however the state is planning another budget revision in August, so information will be delayed. The loss of state

revenue impacts Proposition 98 funding model expectations and the cost of living adjustment (COLA) has been suspended for the next three years for the Local Control and Funding Formula (LCFF) and categorical programs. Because the state could experience cashflow issues, June funding will not arrive until July and three months of payments will be delayed next year, causing the need for the District to borrow in order to meet its obligations. In addition to a zero COLA in 2021/22 and 2022/23, there will be a negative ten percent COLA applied to the LCFF base in 2020/21. Mr. Peschek discussed how these projections will impact the District budget for the next three years, greatly increasing the annual deficits, and said the Board and staff are working to identify reductions and efficiencies. If the District makes no changes prior to June, a negative certification will need to be filed. Additional areas addressed in the May revise include lower lottery funding, maintenance of the Special Education base rate, and up to 50 percent cuts to grant funding, including Adult Education, the Career Technical Education Incentive Grant, and the Strong Workforce Program. The governor recommended reduced employer contribution rates to the retirement systems and said additional federal aid would restore the ten percent cut to the LCFF.
