- ◆ Analysis of induction credentials by Induction Director and Hart Credentials Analyst to determine recommendation for Clear credential
- ◆ Recommendation of Clear credential upon satisfactory completion of requirements for CASC Induction Inquiry system
- ◆ Fee Schedule as follows:

- 2021-2022** - Administrative Induction Candidates charged at \$3000 (to be paid by the administrative candidate in June 2022)
- 2022-2023** - Administrative Induction Candidates charged at \$3000 (to be paid by administrative induction candidate in June 2023)

Granada Hills Charter High School to provide the following:
