Dear Dr. Moore:

Pursuant to Assembly Bill (AB) 1200 (Chapter 1213/Statutes 1992), AB 2756 (Chapter 52/Statutes 2004), and Government Code (GC) Section 3547.5, the Los Angeles County Superintendent of Schools (County Superintendent) has reviewed the William S. Hart Union High School District's (District) "Public Disclosure of Proposed Collective Bargaining Agreement" (Disclosure) concerning a Memorandum of Understanding (MOU) with the California School Employees Association and its Hart Chapter 349 (CSEA). The agreement covers the period of July 1, 2020, to June 30, 2021, and is scheduled for the Governing Board's action on August 4, 2021.

The agreement provides for a one-time off-schedule salary payment of \$2,500 to each active and eligible CSEA member employed five (5) hours or greater, and prorated for unit members employed less than five (5) hours or unit members hired during the 2020-21 school year, and providing services to the District on June 1, 2021. The District's financial analysis, as reflected in the Disclosure, projects it will meet the required reserves during the term of the agreement.

Pursuant to Education Code Section 42142, within 45 days of a collective bargaining settlement, the District Superintendent must send to the County Superintendent any revisions to the District's current budget to fulfill the agreement. AB 2756 and GC Section 3547.5(c) authorize the County Superintendent to take specific action if a school district does not process these revisions.
