William S. Hart has (3) Underground Storage Tanks
Tank 1: Diesel, Tank 2: Unleaded Fuel and Tank 3: Waste Oil that fuel the transportation department vehicles, buses and administrative vehicles. Tank 3 Waste Oil is used for the purpose (Waste Oil Only). The School District falls under all Statutes and Regulations listed above.

Service and Testing Agreement

Upon this agreement, **DEL REAL TESTING (DRT)** agrees to perform all service, testing and consultants to William S. Hart Union High School District to help meet the requirements in the statutes and regulations listed above.

Before the date of the last annual Certification of Monitoring Equipment, Spill Containers, Overfill Prevention Equipment and SB989 Secondary Containment Test, **DRT** will give notification to the School District advising of the due date, which is due in April 2022.

DRT shall give notification to the local agency 72 hours (LACDPW Environmental UST Programs) and coordinate with School District Transportation Department Staff on the date and time of the annual Monitor Certification, Spill Containers, Overfill Prevention Equipment, SB989 Secondary Containment inspection.

DRT shall perform a monthly inspection as, the School District Designated UST Operator within 30 days.

Before the date of the last annual Certification of the Vapor Recovery System, **DRT** will give notification to the School District advising of the due date, which is due in February 2022.

DRT shall give notification to the local air district 72 hours (South Coast AQMD) and coordinate with School District Transportation Department Staff on the date and time of the annual Certification of the Vapor Recovery System.

DRT shall provide ALL of services/testing documents to the School District within 30 days.

DRT shall provide ALL testing results to local agency within the specified time limits set by local agencies (LACDPW Environmental UST Programs, South Coast AQMD)

DRT shall provide the School District with work-orders, corrective action, a list of defected equipment in need of service, repair or replacement.
