

CONSULTANT-CLIENT FEE CONTRACT

This CONSULTANT-CLIENT FEE CONTRACT ("Contract") is entered into between Santa Clarita Valley SELPA ("SCV SELPA") ("Client") and John Lucas ("Consultant").

1. Conditions. This contract will not take effect, and the Consultant will have no obligation to provide services, until the Client returns a signed copy of this contract.
2. Scope and Duties. During the 2022-2023 school year, as requested by Client, Consultant will provide fiscal consultation, support and training to SELPA staff.
3. Hold Harmless and Indemnification Agreement. Santa Clarita Valley SELPA agrees to defend, indemnify and hold harmless John Lucas from and against all costs, losses, claims, demands, suits, actions, payments and judgements, including legal and attorney fees, arising from personal or bodily injuries, property damage or otherwise, however caused, brought or recovered against the Consultant that may arise for any reason from or during or be alleged to be caused by Santa Clarita Valley SELPA. John Lucas agrees to defend, indemnify and hold harmless, Santa Clarita Valley SELPA, its officers, agents and employees, individually and collectively, from and against all costs, losses, claims, demands, suits, actions, payments and judgements, including legal and attorney fees, arising from personal or bodily injuries, property damage or otherwise, however caused, brought or recovered against any of the above that may arise for any reason from or during or be alleged to be caused by John Lucas.
4. Independent Contractor. Consultant enters into this Contract as, and will continue to be, an independent contractor. All services will be performed only by the Consultant. Under no circumstances will Consultant look to SCV SELPA as his employer, or as a partner, agent, or principal. The Consultant will not be entitled to any compensation, disability insurance, vacation, or sick pay. Consultant will be responsible for providing, at Consultant's expense, and in Consultant's name, unemployment, disability, worker's compensation, and other insurance, as well as licenses and permits usual or necessary for providing services under this Contract. Consultant assumes the full responsibility for the services to be provided under this Contract. Consultant assumes full responsibility for payment of all federal, state, and local taxes or contributions.
5. Consulting Fees & Payments. The Client shall pay the Consultant an amount not to exceed \$5,000.00 for the term of this Contract. If Client and Consultant determine that the need of support surpasses \$5,000.00, this amount can increase. Please see the attached Prospectus and Rate Sheet for a breakdown of specific costs. At the end of each month the Consultant shall submit an itemized invoice detailing the hours and services provided.

- 6. Discharge or Withdrawal. The Client may discharge the Consultant for non-performance or a breach of this contract. The Consultant may only withdraw with the Client's consent, or with good cause. Good cause includes a Client's breach of this Contract; a Client's refusal to cooperate with the Consultant, or to follow the Consultant's advice on a material matter, or any other fact or circumstance that would render the Consultant's continuing representation unlawful or unethical.

- 7. Effective Date. This Contract will take effect when the Client has performed the conditions stated in paragraph 1, but its effective date will be retroactive to the date the Consultant first provided services. The date at the beginning of this Contract is for reference only. Even if this Contract does not take effect, the Client will be obligated to pay the consultant the reasonable value of any service the Consultant may have performed for the Client.
