*Resolution to Reduce the Hours of or Not Reemploy  
Certain Classified Employees for the 2022-2023 School Year*

**Resolution No. 21/22-44**

**WHEREAS**, on March 2, 2022, the Governing Board of the William S. Hart Union High School District (“District”) adopted Resolution No. 21/22-33, authorizing and directing the Superintendent, or designee, to initiate and pursue procedures necessary to eliminate the equivalent of 11.68 full-time classified positions pursuant to Education Code section 45117 due to a lack of work and/or lack of funds;

**WHEREAS**, on or before March 15, 2022, the District properly served notice on the employee(s) listed on “Attachment A” that the District will reduce or discontinue their services for the 2022-2023 school year;

**WHEREAS**, the employee(s) listed on “Attachment A” either did not request a hearing or withdrew their request for a hearing and, therefore, sufficient cause exists for not reemploying them full-time for the 2022-2023 school year.

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Board of the William S. Hart Union High School District as follows:

- A. That the Superintendent, or designee, is authorized and directed to notify those classified employees listed on Attachment A, prior to May 15, 2022, that pursuant to Education Code section 45117, their services will be reduced or discontinued as set forth in “Attachment A” for the ensuing 2022-2023 school year. Said notice shall be given by serving upon the classified employees a true copy of this Resolution.
- B. That the Superintendent, or designee, is authorized and directed to take any other action necessary to effectuate the intent of this resolution and finalize layoffs.
