

Professional Services Agreement

This Professional Services Agreement (the "Agreement") is entered into as of May 27, 2022 ("Effective Date") between AquaPhoenix Scientific LLC ("APS" or "AquaPhoenix"), with its office located 860 Gitts Run Road, Hanover, Pennsylvania 17331, and William S. Hart Union High School District (WSHU) with its office at 21380 Centre Pointe Parkway (individually, each a "Party", collectively, "the Parties").

Whereas, William S. Hart Union provides secondary and HS level curriculum and related materials to its customers which include students as part of its services, William S. Hart Union High School District provides educational kits and materials to students utilizing their curriculum;

~~Whereas, APS is a manufacturer and distributor of supplies including containers, packaging and test equipment, as well as possible raw materials and other educational materials; and APS is able to manufacture, procure, stock and ship products by Stock Keeping Unit ("SKU"), assemble products into kits, customize packaging and shipping needs and provide recommendations on related quality and safety issues;~~

Whereas, William S. Hart Union High School District desires to obtain from APS certain products and services for customers to obtain earlier project initiations, reduction in expedited freight expenses, lowering the risk of inventory backorders and minimizing negative impacts to production/shipping schedules, as such the Parties desire to formalize the annual purchase-order based purchase cycle between them in accordance with the terms of this Agreement.

The Parties hereby agree to the following:

1.0 Statement of Work/Services and Deliverables:

- 1.1 Products.** APS shall provide the schools of the William S. Hart Union High School District with agreed upon products defined by SKU (the "Agreed SKUs") as set forth in Attachment A which shall be incorporated into this Agreement. The Attachment A incorporated upon execution of this Agreement shall reflect the Agreed SKUs and their related details for the 2022-23 school year.
- 1.2 APS Ordering Timeframe.** To ensure prompt delivery, APS will order and provide Agreed SKUs to ensure subsequent delivery to William S. Hart Union prior to the School year beginning in August, and as required afterwards. William S. Hart Union will allow for a minimum 8 weeks for processing and delivery of ordered SKUs.
- 1.3 Purchase Order/Reports.** William S. Hart Union High School District will order the Agreed SKUs listed in Attachment A by requesting a formal quote, which will then be used to issue a purchase order to APS. APS shall include an estimated shipping cost on the quote for the purpose of securing funds for a purchase order. APS will label any invoice, packing slip, or correspondence with the applicable purchase order number.

1.4 Product Delivery to William S. Hart Union. APS shall deliver the quantities of Agreed SKUs ordered by William S. Hart Union High School District pursuant to release of the properly authorized and signed Purchase Orders from William S. Hart Union High School District Union. APS shipments will use APS preferred carrier and shall invoice WSHU the cost of the transport without markup. APS' invoices may include a handling charge not to exceed 5% of shipping costs and shall include applicable California sales tax.

1.5 Product Specification Changes/Recalls. Any changes to products specifications of Agreed SKUs shall be reviewed and approved by WSHU prior to such change being implemented. APS shall notify WSHU in writing of any recalls related to products and SKUs provided to WSHU under this Agreement in a timely manner.

1.6 Sales Tax. Notwithstanding anything herein to the contrary, WSHU shall be responsible for any and all applicable California sales tax on any orders placed with APS.

2.0 Pricing and Payment:

2.1 Pricing. Prices set forth in Attachment A, will remain fixed from the Effective Date through April 30, 2023.

2.2 Payment. Upon receipt of invoices by APS, WSHU shall pay APS under Net30 terms. Payments may be sent to APS, via check or ACH to the address or bank wiring details set forth in the invoice.

3.0 Term: The initial term of this Agreement will take effect upon the Effective Date and will continue through April 30th, 2023, unless renewed or earlier terminated as permitted herein.

4.0 Termination: The Parties may terminate this Agreement as follows:

4.1 Termination for Convenience. WSHU shall have the right to terminate this Agreement for convenience upon ninety (90) days written notice to the APS and APS shall have the right to terminate this Agreement upon one hundred twenty (120) days written notice to WSHU. In the event that the Agreement is terminated by either Party, APS shall be obligated to complete delivery of any SKU products ordered or pre-paid for by WSHU prior to notice of termination and WSHU be obligated to take delivery of any such inventory within 3 months of the termination date and pay any and all non-disputed invoices.

4.2 Material Breach. Either Party may terminate this Agreement, in whole or in part, for the material breach of the other Party if such material breach remains uncured for thirty (30) days after receipt of written notice of such material breach from the non-breaching Party. Notice shall describe the breach in reasonable detail.

4.3 Bankruptcy. Either Party may terminate this Agreement immediately upon written notice if a Party becomes insolvent, files a petition in bankruptcy or makes an assignment for the benefit of its creditors.

5.0 Transition Assistance: In the event of any termination or expiration of this Agreement, at a minimum APS shall cooperate in good faith with the transition to a new provider (if any) of the products and services provided by APS hereunder.

6.0 Confidentiality: Each Party shall treat the other Party's non-public information including, customers and student data, finances, pricing and business plans and strategies as confidential. A receiving Party shall not disclose such confidential information without prior written permission from the disclosing Party, except that such information may be shared with a person who has a bona fide need to know the information provided such person is bound by terms of confidentiality at least as restrictive as those used herein.

7.0 Warranties: APS represents and warrants that: (i) its services will be provided in a professional and workmanlike manner consistent with good business practices and generally accepted industry standards; (ii) all products provided hereunder will comply with all applicable laws, including the U.S. Consumer Product Safety Improvement Act, the Globally Harmonized System of Classification and Labelling Chemicals and Department of Transportation Regulations.

8.0 Indemnity: Each Party ("Indemnitor") shall indemnify, defend and hold harmless the other Party and its affiliates and respective directors, employees, officers and subcontractors ("Indemnitees") from and against any and all third party liabilities, claims, actions, fines, damages, losses, costs and expenses including reasonable attorneys' fees ("Claims") to the extent such Claims are caused by or resulting from Indemnitor's negligent acts, errors or omissions or willful misconduct, except to the extent caused by the Indemnitee. For the avoidance of doubt, APS shall have no indemnification obligation under this Agreement arising out of or in connection with Claims that are caused in whole or in part by WSHU's customers, provided APS complied with applicable law and WSHU's written instruction.

9.0 Indemnification Procedures: With respect to a Claim for which indemnification is sought, the Indemnitee shall provide Indemnitor with prompt written notice, tender of the defense or settlement, and full cooperation in the defense. Indemnitor will keep Indemnitee reasonably informed of the status of the Claim. Failure to give prompt written notice of a Claim shall not affect the Indemnitee's right to indemnification unless the failure materially and adversely affects the rights, remedies or liability of the Indemnitor. The Indemnitor shall not make a compromise or settlement of a Claim without the Indemnitee's consent.

10.0 LIMIT OF LIABILITY: APS' MAXIMUM LIABILITY AND OBLIGATION TO WSHU SHALL BE LIMITED TO THE RECOVERY OF ACTUAL DIRECT DAMAGES NOT TO EXCEED THE AMOUNT OF FEES PAID UNDER THIS AGREEMENT DURING THE PRIOR TWELVE (12) MONTH PERIOD. NOTWITHSTANDING ANYTHING TO THE CONTRARY HEREIN, IN NO EVENT SHALL WSHU OR APS BE LIABLE TO THE OTHER FOR ANY INCIDENTAL, INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES UNDER THIS AGREEMENT EXCEPT FOR DAMAGES OR LOSSES ARISING FROM THIRD PARTY INDEMNITY LIABILITY OR DAMAGES OR LOSSES ARISING FROM A PARTY'S WILLFUL MISCONDUCT, GROSS NEGLIGENCE OR RECKLESS CONDUCT.

- 11.0 Insurance:** Each Party shall maintain commercial general liability insurance (naming the other Party and their Indemnitees as additional insureds) with limits of liability not less than \$2,000,000 per occurrence and including liability coverage for bodily injury or property damage; and professional liability insurance (including errors and omissions coverage) with liability limits not less than \$1,000,000. Each Party's insurance shall be primary, and any applicable insurance maintained by the other Party shall be excess and non-contributing. Each Party shall provide the other Party with properly executed certificate(s) of insurance upon request and shall notify the other Party no less than thirty (30) days in advance, of any reduction or cancellation of the required coverages.
- 12.0 Independent Contractor:** APS is an independent contractor under this Agreement and not acting as an agent of, or in a joint venture with, WSHU. APS shall be responsible for filing any tax returns in connection with the products or services provided.
- 13.0 Successors and Assigns:** APS shall not assign this Agreement or any right or obligation hereunder without WSHU's prior written consent, and any attempted assignment without WSHU's prior written consent shall be deemed void. This Agreement shall be binding upon and inure to the benefit of the successors of WSHU and of APS.
- 14.0 Waiver:** Failure of either Party to insist in any instance upon strict performance by the other Party of any term, condition or obligation set forth in this Agreement shall not be deemed a waiver of such or any other provision of this Agreement.
- 15.0 Execution and Modification:** This Agreement shall be considered executed when signed by duly authorized representatives of both Parties. Modifications shall be made only by written agreement of the authorized representatives of the Parties.
- 16.0 Disputes:** In the event of a dispute, the Parties agree to use good faith efforts to resolve the issue by progressively escalating the matter to its senior management. In the event a dispute is unresolved, the Parties shall use mediation to resolve the dispute. If mediation is unsuccessful, the Parties agree to binding arbitration to be conducted in California. This Agreement shall be governed by the laws of the State of California, excluding its conflict of laws rules.
- 17.0 Enforceability:** If any provision of this Agreement is held invalid by law, this shall not affect the other provisions of this Agreement, the application of the invalid provision to any circumstance other than that, with respect to which this Agreement was found to be unenforceable, or the validity or enforceability of this Agreement as a whole.
- 18.0 Headings:** Section headings are not to be considered a part of this Agreement and are not intended to be a full and accurate description of the contents hereof.
- 19.0 Force Majeure:** Neither Party shall be responsible for delays, failure, or omissions due to any cause beyond its reasonable control, howsoever arising and not due to its own negligence or intentional misconduct and which cannot be overcome by the exercise of due diligence, including, but not limited to labor disturbances, riots, fires, earthquakes, floods, storms, lightning, epidemics,

war, disorders, hostilities, expropriation of confiscation of properties, interference by civil or military authorities or act of God.

20.0 Entire Understanding: This Agreement together with Attachment A represent the entire understanding of the Parties hereto and supersedes all prior written or oral agreements with respect to the subject matter hereof.

21.0 Service Level Agreements ("SLA"): APS shall meet the following SLAs. If the SLAs are not met, APS will propose a plan to address the deficient SLA and shall remediate the issues within a timeframe not to exceed one (1) month. Any remediation costs will be borne by APS.

21.1 Delivery Timeline Compliance. APS shall communicate openly and timely in informing WSHU of any backordered items or any items that may not arrive in time to meet the curriculum timelines established by WSHU. Upon issuance of WSHU Purchase Orders, APS shall provide weekly updates on an item specific level via spreadsheet to WSHU's appointed purchasing coordinator. Items of concern to WSHU shall be collaboratively addressed by conference call and/or email to explore potential remedies.

21.2 Quality of Materials SLA. Quality of the materials provided by APS shall be monitored by, among other things, measuring the total number of complaints received by WSHU's customer related to the materials shipped by APS to each grade level. APS shall have the goal of a customer satisfaction rate of 95%. In the event that the customer satisfaction rate falls below 95%, APS shall refill the impacted orders in an expedited manner at APS' expense.

21.3 Shipping Errors. If APS ships incorrect SKU products to WSHU's customers (for example, the wrong item is shipped by mistake) WSHU shall notify APS within 2 weeks of product receipt. WSHU's remedy and APS liability for such errors shall be limited to replacing the impacted order in an expedited manner at APS' sole expense (or refunding WSHU for the items, if APS is unable to reasonably replace them) and APS shall pay for any restocking or other costs incurred as a result of the shipping error. For the avoidance of doubt, any replacement shall be with SKUs with same specifications that were ordered unless otherwise mutually agreed.

22.0 Notices: Any and all notices, demands, or other communications required or desired to be given hereunder by any Party shall be in writing addressed to the Party to whom such notice, demand or other communication is to be given as follows.
