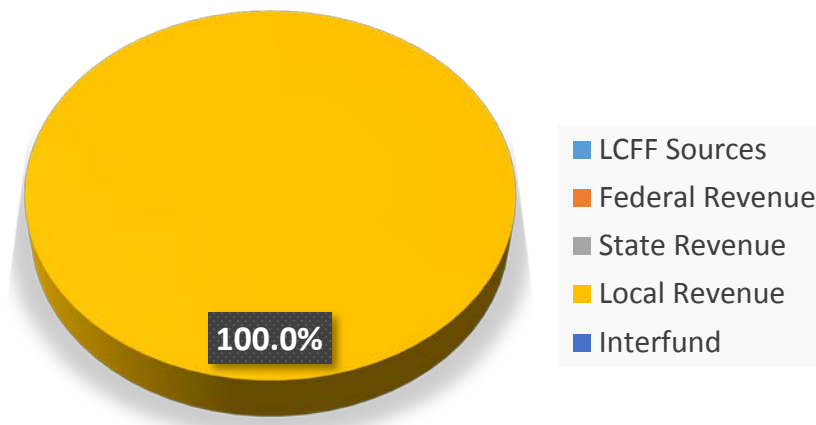

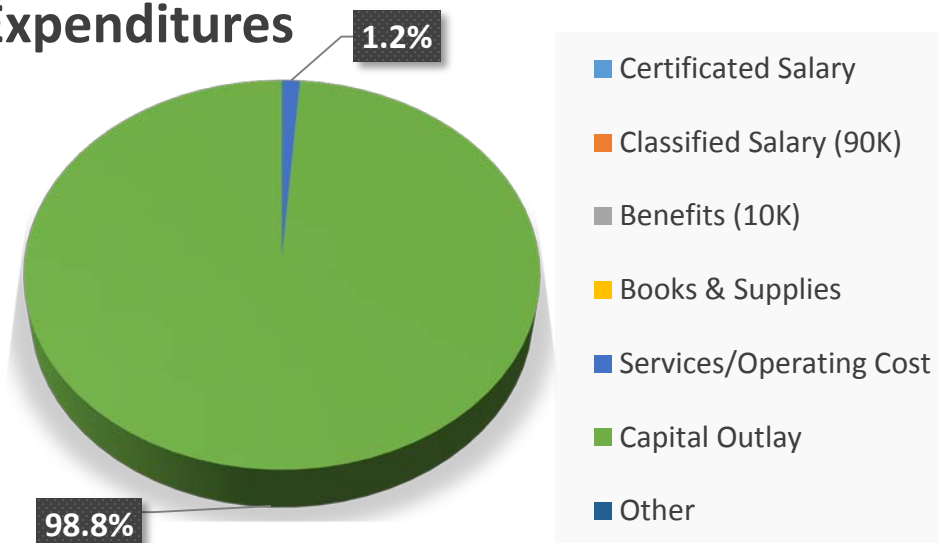
Capital Projects Fund for Blended Component Units – CFD's (49)
