

RESOLUTION NO. 18/19-10

COMPETITIVE SPORTS AUTHORIZATIONS

WHEREAS, Education Code Section 44258.7(b) allows a full-time teacher who holds a credential in a subject other than physical education *to coach a competitive sport for which the students receive physical education credit* for one period a day, if the teacher has completed a minimum of 20 clock hours of first aid instruction appropriate to the specific sport; and

WHEREAS, the teachers listed below are full-time teachers who hold a credential in a subject other than physical education, and have completed the required 20 clock hours of first aid instruction appropriate to the specific sport:
