**SCOPE:**

- Install (2) 70" OFE NEC Displays with OFE mounts for main teaching wall displays
- Install (6) 43" OFE NEC Displays with OFE mounts for breakout huddle tables
- Utilize Existing Power and Surface Raceway throughout the room
- Utilize Existing AV Rack inside the room
- Provide Input for Teachers Computer (HDMI)
- Provide Wireless Connection for Teacher or student to connect laptop or smart phone as a source
- Provide Surface Mounted Touch Screen Panel at Teachers Desk
- Provide (2) New Data drops to the AV Rack for Control and Wireless Device
- Provide (2) Wall Mounted Speakers on the main teaching wall
- Distribute Teachers signal to all displays (8 total) over cat6 HDMI transmitters
- Program Panel to be able to switch the huddle tables to switch over to local HDMI from desk locations
